## Member Education Needs on Ecosystems Markets

By now you may have read <u>Rod Snyder's op-ed</u> this week in Agri-Pulse about voluntary ecosystems markets or read his mention of this committee's potential role in the member communication that went out on April 19. An excerpt is below:

"Last but certainly not least, **ecosystem service markets and supply chain sustainability programs must be farmer friendly**. There is already significant confusion in the countryside around eligibility requirements, payment and contract terms, and data ownership and privacy considerations. Agriculture organizations and especially commodity groups are in an important position to help demystify this space for farmers once the terms of engagement are clear. In the coming months, Field to Market's Education and Outreach Committee will partner with relevant organizations to develop useful information to help farmers and supply chain companies effectively navigate these opportunities. "

This will be a primary topic of our May committee call and we will likely have a breakout session addressing this at the June plenary.

Cross-Sector Dialogues Just announced: From Soil Health to Soil Wealth: Accelerating Regenerative Agriculture for a Resource-Positive Future

June 29, 1:00 – 3:30 PM EDT | Remote

As more companies establish regenerative agriculture goals for their supply chains as a solution to reverse nature loss and combat climate change, our industry is working to support farmers in scaling these practices from niche to norm. This Cross-Sector Dialogue will build a shared understanding about how sustainable, regenerative and conservation agriculture systems intersect while exploring mechanisms to accelerate resource-positive outcomes.

This event will be registered as an independent dialogue within the UN Food Systems Summit, and a summary will be formally submitted to USDA and the United Nations on game-changing solutions for Action Track 3: Boost Nature-Positive Food Production. Join with visionary leaders from grower groups; agribusinesses; financial institutions; conservation NGOs; food, beverage and retail companies; government and academia to shape a roadmap toward a more regenerative future where farmers and nature thrive.
